**ACCEPTABLE USE GUIDELINE
For INTERNET ACCESS by STUDENTS of the
Catholic District School Board of Eastern Ontario's Network**

The students of the Catholic District School Board of Eastern Ontario may freely use, with staff supervision, the Board's Wide Area Computer Network for Internet access. This access will enable students to explore databases, libraries, and exchange information over the Internet with users throughout the world. Our goal is to guide our students in navigating through the world wide web for beneficial purposes and to minimize the possibility of accessing materials that may be illegal, defamatory, inaccurate, or potentially offensive.

Access privileges to the network will be given to students who agree to act in a considerate and responsible manner. All students must comply with the following guidelines and obtain parental permission in order to access the Internet.

Internet Guidelines

Internet accounts may be used only by authorized users for educational purposes only. Users must act responsibly and respect the integrity of the Catholic District School Board of Eastern Ontario's academic technology goals.

The following are prohibited:

- Sending downloading, or displaying offensive messages or pictures
- Using obscene language, harassing, insulting, or attacking others
- Violating copyright laws
- Using another person's password
- Trespassing in another person's folders, work or files
- Using the account for personal profit or gain
- Abusing computer equipment belonging to the school

Violations will result in:

- Loss of access
- Disciplinary action
